4. The bank may at any time before the property (s) is sold withdraw the property from the sale.
5. For every successful bid, the purchaser is required to make payment of 25% of the bid amount shall be transferred/deposit in BDB Auction Sale Proceeds Account no. 0010200040004 immediately after the auction. The balance is to be paid on or before the expiry of 10 working days from the date of auction.
6. The successful bidder shall lift the items within 5 days from the day of making full payment. BDB will not be responsible for lost/misplacement of the items.
7. The highest bidder shall be purchaser and he/she shall not be allowed to retract bid(s). If the highest bidder retracts his/her bid, the EMD shall be forfeited.
